Medical emergencies occurring in the dental office can be stressful and frightening, not only for the patient, but also for the entire dental team. This course is designed for dentists and staff to prepare their office in accordance with American Dental Association recommendations. The appropriate preparatory steps to take before a crisis occurs will be covered. Then techniques to identify and respond to the eleven medical events dental offices are likely to face will be addressed. THE WEED OF TODAY IS NOT YOUR MOMMA'S WEED

This lecture will be devoted to marijuana. Thirty-two states have legalized marijuana for medical use. Ten states and the District of Columbia have legalized marijuana for recreational purposes. Inevitably, some of these marijuana users will be treated by the dentist or hygienist. What is it? Does it have any medicinal use? Is marijuana addicting? What are the effects of marijuana on driving ability? What are the effects of marijuana on intellectual development? What are "shatter," "wax," "dab," or "scat," and how do they differ? Is edible marijuana as effective as smoking or vaping? This presentation will discuss some of the concerns about marijuana use/abuse, and its bearing on dental treatment.

CLUES TO YOUR PATIENTS' HEALTH: LOOK IN THEIR BAG OF PILLS

Your patients are living longer thanks to their medications, but many of the physician-prescribed medications used by your patients have dental implications and side effects affecting your treatment plan. This presentation includes the indications, contraindications, and side effects of the most common physician-prescribed medications. Many of these medications were not approved when you took your pharmacology course in dental school. These medications represent one third of all prescriptions taken by your dental patients, and familiarity with these drugs will provide the dental practitioner with a better appreciation for the health profile of your dental patient.

-  Prescription, OTC medications, and foods that could adversely interact with dental drugs
-  Why your patient is taking their medications
-  What oral side effects may be caused by these medications
-  When not to prescribe NSAIDs

He serves on the Maryland State Dental Association's Well-Being Committee, is an active member of Phi Kappa Phi, Omicron Kappa Upsilon Honorary Dental Society, the American College of Dentists, International College of Dentists, and an honorary member of the Thomas B. Hinman Dental Society. He was the recipient of the 2008 Gordon Christensen Lecturer Recognition award presented by the Chicago Dental Society.

Distinguishing the Benign from the Deadly: Oral Pathology Update

Fasten your seatbelts! This lecture will be heavy on pictures with the goal of illustrating a variety of conditions that can be encountered frequently in the dental office. Growths that can be seen in a wide spectrum of ages from children to the elderly will be reviewed. This lecture will describe HPV infections, the natural history of the infection and which HPV-associated lesions are of most concern. The presentation of oropharyngeal carcinoma will be discussed and contrasted with oral cavity cancer – specifically cancers that arise on the lateral border of the tongue. Risk factors for HPV-related cancers and review of the current HPV vaccines available will be reviewed. The role of oral health care providers in screening for these cancers will be discussed.

-  How to develop a differential diagnosis for common oral growths
-  Understand how color, shape and size can aid in identifying the growth
-  Learn which lesions are normal variations and when to refer for biopsy
-  Be familiar with the terminology of leukoplakia and erythroplakia and how to distinguish these entities from masqueraders
-  How to develop an organized approach to oral examinations and recognize the most common areas for oral cancer development
-  Understand the role of HPV in cancer

About DR. SUSAN MULLER

Dr. Susan Muller is a graduate of Medical University of South Carolina School of Dental Medicine and completed her Oral and Maxillofacial Pathology training at Emory University, and a Head & Neck Pathology fellowship at the University of Pittsburgh. Dr. Susan Muller retired from Emory University October 2013 and is Professor Emeritus and is currently in private practice with Atlanta Oral Pathology. Dr. Muller enjoys lecturing on Oral Pathology and has lectured throughout the world. She also published on her favorite topics and has more than 200 publications. Dr. Muller is Past President of the American Academy of Oral and Maxillofacial Pathology and the North American Society of Head and Neck. She has served on the American Board of Oral and Maxillofacial Pathology and was Editor-in-Chief of Head and Neck Pathology from 2008-2018.

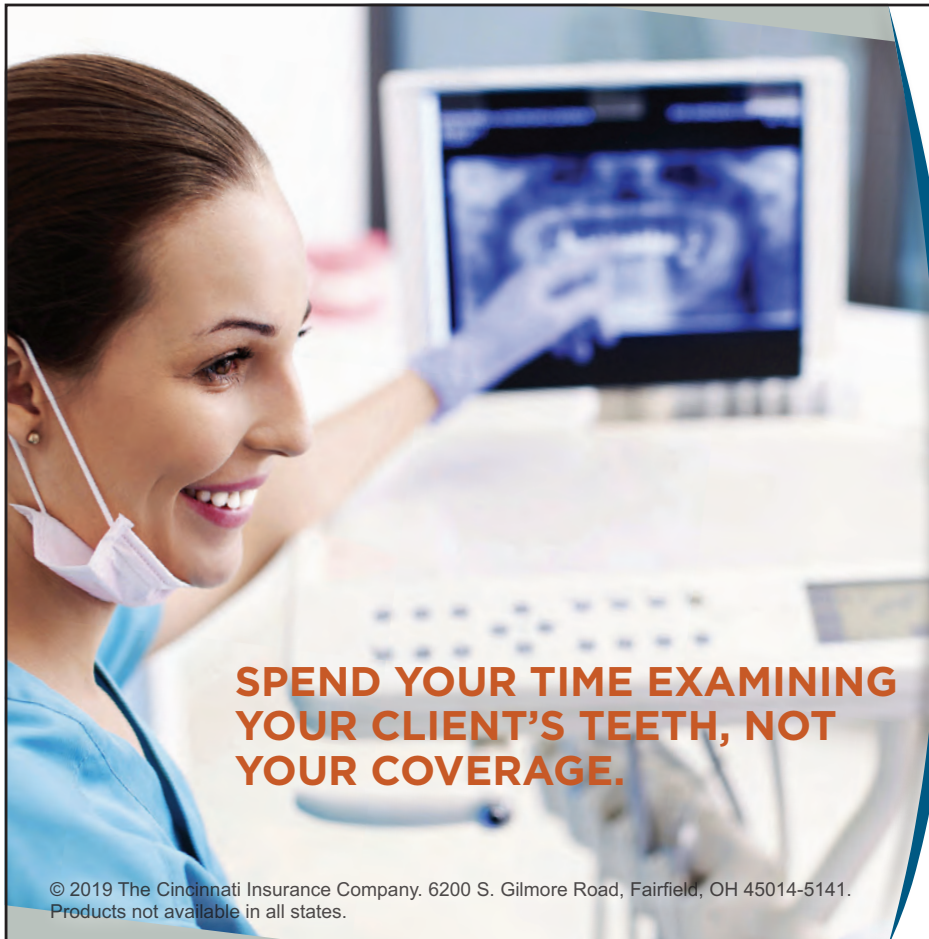
